“ARTICLE V NOMINATIONS, ELECTIONS, ELIGIBILITY, ABSENTEE BALLOTS, FISCAL YEAR

#### Section 4

- B. In the event an elected office has been declared vacant, the Election Committee will be notified and it will become their responsibility to notify all members of said vacancy via club newsletter or general mail. This notification will contain dates for nomination and election, and eligibility requirements. Elections will be held at a general membership meeting following notification.
