

### PROPOSED CHANGE TO BYLAWS ARTICLE XV THIRD READING - November 2022

#### **CURRENTLY READS:**

#### ARTICLE XV SECTION I RVs, CAMPERS, TRAVEL TRAILERS AND MOTORHOMES

For this article only - RVs, Campers, Travel Trailer (s) and Motorhomes will mean a camper and identified as same.

For this article only – A day is defined to be any overnight period.

For this article only – A member is defined as a social, auxiliary or full.

Members may bring their camper and be assigned a spot for the time visiting the club only by the Vice Commodore or his/her designee.

Before a member can bring his/her camper to the property they must provide to the Vice Commodore his Name, Address, Phone Number, Copy of the Registration and Copy of the Insurance Certificate.

For club events such as Luau, 4<sup>th</sup> of July Fireworks, Regatta or other club events that the officer board so authorize campers are allowed to be on property for a total of 4 days per event or regardless of the event 8 days maximum per month.

In the event the camper is on the property past the 4 days of the club event the member must pay \$5.00 per day for every day up to a maximum of an additional 4 days. (8 days maximum per month)

For non-club events a member may have their camper at the club for the maximum 8 days per month. Will pay \$5.00 per day for every day up to the maximum.

In the event the camper is on the property longer than the maximum of 8 days for any month, the Vice Commodore must have the camper removed from the property at the member's expense. This includes all towing charges and other charges that may be levied against the club. (January 2018)

#### **CHANGED TO READ:**

#### ARTICLE XV Camper and Trailer Parking

Section 1. Camper Parking

For this section only – RVs, Travel Trailers, Motorhomes and/or Tents will mean camper and identified as same.

For this section only – A day is defined to be any overnight period.

For this section only – A member is defined as a social, social family, full or full family.

Members may bring their camper and be assigned a spot for the time visiting the club only by the approval of the Commodore, Vice Commodore or a person designated by the Commodore.

Before a member can bring his/her camper to the property they must provide in writing to the responsible person above their name and the dates the camper will be on the club property. Registration and Certificate of Insurance must also be provided for motorhomes and travel trailers.

Upon approval, a member may have their camper at the club for a maximum of 8 days per month but no more than 8 consecutive days at the rate of \$5.00 per day.

For club events such as Luau, 4<sup>th</sup> of July Fireworks, Regatta or other club events that the officer board so authorize campers are allowed to be on property for a total of 4 days per event at no charge. However, these days shall count towards the member's 8 day maximum.

In the event the camper is on the property longer than 8 days either per month or consecutively, the Commodore or Vice Commodore may have the camper removed from the property at the member's expense. This includes all towing charges and other charges that may be levied against the club. If the camper remains beyond the 8 day maximum, the daily rate will be increased to \$50.00 per day until the camper is removed.

Any special exceptions to the requirements of this section must be requested in writing to the Commodore and approved by a majority vote of the Officer Board.

#### Section 2. Trailer Parking

For this section only – Boat Trailers (with or without boat), utility trailers and any other type of trailer not used for camping will mean trailer and identified as same.

For this section only – A day is defined to be any overnight period.

For this section only – A member is defined as a social, social family, full or full Family.

Requests to park a trailer on club property shall be made to the Dock Master or Assistant Dock Master in writing and include the members name, the dates the trailer will be on club property and the trailer license plate number/boat name.

Upon approval of the Dock Master or Assistant Dock Master, a member may park their trailer at the club free of charge up to a maximum of 8 consecutive days.

In the event the trailer is on the property longer than the maximum of 8 consecutive days, the Dock Master may have the trailer removed from the property at the member's expense. This includes all towing charges and other charges that may be levied against the club. If the trailer remains beyond the 8 day maximum, the member will be charged \$25.00 per day until the trailer is physically removed.

Any special exceptions to the requirements of this section must be requested in writing to the Dock Master and approved by a majority vote of the Officer Board.

### PROPOSED BYLAW CHANGE ON BORROWING CLUB EQUIPMENT (SECOND READING – November 2022)

#### Change to Article XIV, Club Rules, Item #3:

#### **Currently reads:**

3. <u>Borrowing Club Equipment.</u> Any use of Club equipment or the Club premises by the members of the Club must be approved by the Officers in their regular meeting. Permission will be given in writing to the member upon request in writing by the member.

#### Change to read:

3. <u>Borrowing Club Equipment.</u> Club equipment, e.g. tables, chairs, kitchen equipment, must not be removed from the club premises without the prior approval of the Sergeant At Arms. Requests to borrow such equipment should be submitted to the Sergeant At Arms in writing listing the items involved and the date of return. The borrowing member will be financially responsible for any loss or damage to the borrowed items.

#### Change to Article VI, Section 16:

#### **Currently reads:**

Section 16 <u>Sergeant At Arms</u> The Sergeant At Arms shall be responsible for maintaining order at all club general meetings, including, if necessary, the removal of any member who is being disruptive during a meeting, after said member has been appropriately warned beforehand. The Sergeant At Arms shall be responsible for insuring that all members are signed in at membership meetings as well as insuring that only members of good standing and representatives from the Auxiliary and Social membership are present in the meetings.

The Sergeant At Arms shall be responsible for the security of the club, grounds and properties/ equipment (this includes any/all loaning/usage of club equipment), including security functions at all club parties. He/she shall be responsible to implement changes to the security of the club as needed, with appropriate approvals as required by either the officer's board or the membership.

#### Change to read:

Section 16 <u>Sergeant At Arms</u> The Sergeant At Arms shall be responsible for maintaining order at all club general meetings, including, if necessary, the removal of any member who is being disruptive during a meeting, after said member has been appropriately warned beforehand. The Sergeant At Arms shall be responsible for insuring that all members are signed in at membership meetings as well as insuring that only members of good standing and representatives from the Auxiliary and Social membership are present in the meetings.

The Sergeant At Arms shall be responsible for the security of the club, grounds and properties/ equipment including security functions at all club parties. He/she shall be responsible to implement changes to the security of the club as needed, with appropriate approvals as required by either the officer's board or the membership.

The Sergeant At Arms shall also be responsible for any/all loaning/usage of club equipment per Article XIV, Item 3, subject to any guidelines/restrictions/fees directed by the Officer Board or membership.

#### PROPOSED CHANGE TO BYLAWS REGARDING CLARIFYING WORK HOURS AND EVENT HOUR SIGNUPS (SECOND READING - November 2022)

#### Article IX, Section 7, Paragraph 1:

#### **Currently Reads:**

Work Hours The 12-month period for which work hours shall be tallied shall be from November 1<sup>st</sup> to October 31<sup>st</sup>. Each member, except those excused by the Officers and/or the By-Laws, shall be required to work a minimum of twenty (20) hours at the Boat Club and twelve (12) hours of which will be completed by July 10<sup>th</sup>, six (6) hours to be completed by October 31<sup>st</sup>. The remaining two hours shall be worked at the DBBC Luau, Fireworks Party (if held) and/or the DBBC Steak Roast. These "work hours" will be in the improvement or maintenance of the Club property (docks, grounds, or buildings) or any work designated by the Officer Board. (August 2020)

#### **Changed to Read:**

Work Hours The 12-month period for which work hours shall be tallied shall be from November 1<sup>st</sup> to October 31<sup>st</sup>. Each member, except those excused by the Officers and/or the By-Laws, shall be required to work a minimum of twenty (20) hours at the Boat Club. At least twelve (12) hours of which must be completed by July 10<sup>th</sup> with the remaining hours to be completed by October 31<sup>st</sup>. A minimum of two (2) hours of these hours shall be known as "party hours" and must be worked at an Officer Board designated event with work signup sheets such as the DBBC Luau, Fireworks Party (if held) and/or the DBBC Steak Roast. If a member fails to show up for their previously signed up work time, the missed work hours will be billed as additional unworked party hours. Other work hours may be worked in the improvement or maintenance of the Club property (docks, grounds, or buildings) or any other work authorized and approved by a club officer.

#### PROPOSED CHANGE TO BYLAWS REGARDING HALL/EQUIPMENT USAGE BY SOCIAL MEMBERS:

#### (SECOND READING – November 2022)

#### Article X, Membership, Section 5, Social Membership, Paragraph G.

#### **Currently reads:**

<u>Access / Privileges</u> – Social members will receive a key card, and shall be afforded the same privileges to bar, food, and hall usage as regular members.

#### Changed to read:

<u>Access / Privileges</u> – Social members will receive a key card, and shall be afforded the same privileges/access to the club bar and food as full members.

Social members may not borrow/use club equipment/hall prior to completing a minimum membership period of one year (12 consecutive months) and be current on all club obligations unless approved in advance by a majority vote of the Officer Board.
